



## CONDITIONS FOR TCMA SUBSIDIES TO ATTEND YALE 2012

- ELIGIBILITY:** Current financial professional membership of TCMA.
- PURPOSE:** To assist TCMA members to attend 2012 global chaplains' conference at Yale University, New Haven, Connecticut.
- APPLICANT:** Satisfy selection criteria  
Submit curriculum vitae  
Agree to refund the subsidy within one month should the applicant, for whatever reason, be unable to attend
- SELECTION CRITERIA:** Personal and leadership qualities  
Evidence (for example, from the leader of religious body or university who has appointed her/him) of the probability of remaining as chaplain/campus minister for at least 2013.  
In the event that there are more applicants than the number of subsidies available, applicants' potential and willingness to contribute to the furtherance of TCMA ideals in Australia will be taken into account. Ability/willingness to: help organise the 2013 or 2014 TCMA annual conference; help with the production of the journal; help maintain the email list and/or website; maintain the directory; provide advice from the perspective of a non-Christian religion; would be well regarded, but other skills etc would also be considered. Supply details of, at least, one confidential referee who can be contacted by the selection panel.  
If receiving financial assistance from another source, apart from self-funding, details of such an amount and a budget to be supplied relating to the cost of attending the International Conference.
- WRITTEN REPORT:** A condition for receiving a subsidy is that a written report on the conference or journal article from material presented at the conference by the recipient to be submitted to the TCMA executive ***within the three month period following the conference.*** The report should have the potential for being published in the TCMA Journal.
- SELECTION PANEL:** At least two members of the executive of TCMA, none of whom are applying for a subsidy.
- DEADLINE FOR 2011:** Applications must be in the hands of the selection panel by **28 October, 2011** and will be notified of a successful application by **4 November 2011.**
- APPLICANTS:** All applications must be on the form below and application form and attachments as outlined should be faxed or emailed, with originals sent by mail to:
